#### **Annual HOA Meeting Notice**

The Lake Erie Shores Homeowners' Association Annual Meeting was attempted to be held at the Painesville Township Park, located at 1025 Hardy Road, on Thursday, March 24, 2011 at 7:00 p.m. Unfortunately, we did not have a quorum and therefore no Association business could be conducted as outlined in our bylaws. We were 44 houses short of a quorum and that represents 20% of the residents.

The make-up meeting is scheduled for Thursday April 21<sup>st</sup> and a meeting notice will be mailed to all residents.

If you signed in at the 3/24 meeting, or you previously submitted a proxy, you are already counted towards the quorum. There are several options available to these residents to vote on Association business at the upcoming meeting:

- 1. Show up at the meeting this is the easiest scenario.
- 2. If you attended the 3/24 meeting, but cannot make the 4/21 meeting, complete a proxy and assign your vote to another eligible voting member (this includes specific Board members).

If you attended the 3/24 meeting but cannot make the 4/21 meeting, and do not complete a proxy, you will count towards the quorum but your home will not have a vote.

If you did not attend the 3/24 meeting, you did not complete a previous proxy and you do not plan on attending the 4/21 meeting, there are several options:

- 1. Complete a proxy and assign your vote to another eligible voting member (this includes specific Board members)
- 2. Complete a proxy and check the box to abstain from voting but count towards a quorum

Proxy's should be mailed to the homes that did not complete a proxy previously, or who were not present at the March 24 meeting. A proxy is also attached to this newsletter for convenience.

We need help as we need 20% more of our residents to show up or complete a proxy to satisfy the quorum requirements.

This will ensure that your votes are cast. **IF THE PERSON DESIGNATED AS PROXY DOES NOT ATTEND THE MEETING, THE PROXY MAY BE USED ONLY FOR THE PURPOSE OF ESTABLISHING A QUORUM**.

You may revoke or change your proxy at any time prior to its use at the meeting. There are three ways you may do so:

- A. Give the Management Company a written directive to revoke your proxy.
- B. Submit a later dated proxy anytime prior to the meeting.
- C. Attend the meeting and vote in person.

Proxies will <u>be deemed invalid if Proxies</u>: (1) have changes that are not initialed by the Homeowner; and (2) are not filled out exactly as required, dated, and signed by the Homeowner.

I/we understand that if a quorum is not achieved at the proposed time for the election meeting, this Proxy will continue to be valid for one month from the date of my/our signature(s).
